Both the Clerk and Cllr. L Hamilton-Street made it clear that the building was fit for purpose and the public were not in any danger. APC puts the safety of its residents first.

A discussion took place where councillor questions were answered and any concerns over what Cllr Verrinder had raised were addressed.

Cllr. Reigate brought the discussion to a close.

Cllr Alan Evans wanted to make the committee aware of the numbers of people that were vaccinated against COVID-19 at Angmering Community Centre which was 106,812. He gave examples of how good this number was in comparison to other areas. He also wanted to make the point that over the period that the vaccinations were taking place no ADC councillors visited the site to show their support, despite him emailing all 3 councillors and he stated he was very disappointed in this.

6 21/202 CHAIRMANS REPORT

No questions were asked.

7 21/203 REPORT FROM THE WEST SUSSEX COUNTY COUNCILLOR

Cllr. Urquhart gave an update on the following:

Cycle Path in Bramley Green – the repairs are due to start any day now on the unsafe cycle path. She also suggested that a photo be taken once the area had been completed as the office and councillors worked hard to push the repairs through due to receiving several notifications about accidents occurring due to the "slippy" nature of the cycle path.

<u>Action</u>: Picture opportunity to be arranged. Including Cllr. Urquhart.

The work on the A259 is still on track and due for completion in November 2022.

TRO removal of the bus lane in Dappers Lane is out for consultation.

WSCC are currently subsidising the purchase of compost bins, information can be found on their website.

The Recycling Centres are now open until 6pm and Worthing Recycling Centre is open 7 days a week, these are the new summer opening times. Cllr. R Evans wanted to know about the charges for recycling household building material. Cllr. Urquhart explained that there was no charge at the WSCC Centres and hadn't been for a while. She also advised that the pre-

booking system was still working very well and the background to why it was brought in. The feedback received from the public was to keep the booking system in place.

Cllr. L Hamilton-Street wanted to bring up his concerns over pot holes and the amount of times the same pot holes were having to be repeatedly filled in. Cllr Urquhart will look into the matter as this should not be happening.

Cllr. Urquhart left the meeting at 19:54.

8 21/204 REPORT FROM THE ARUN DISTRICT COUNCILLORS

9 21/205 NEIGHBOURHOOD PLAN

There are no updates regarding the Neighbourhood Plan.

10 21/206 UTILITIES CONNECTIONS – MAYFLOWER PARK

Cllr. Reigate explained what this was concerning and what was needed to be discussed tonight. The Clerk then clarified what the expenditure was for and why it was needed, she also explained that the monies to pay for the report were available.

Cllr. R Evans talked about this project using sustainable power but felt this report was needed.

RESOLUTION: Cllr. L Hamilton-Street **PROPOSED** that £2k was made available for the report. Cllr. R Evans **SECONDED**, and **ALL AGREED**

Action: Instruct the report to be undertaken.

11 21/207 FLETCHERS FIELD PLAY PARK

Cllr. Reigate gave the history of this park as well as information on the land owner, St Margaret's Church. Currently the play park is owned and maintained by ADC and APCs only involvement is cutting the grass on Fletchers Field around the play park.

The Clerk gave an overview of the report that was submitted in 2019 and explained why this item was on the agenda drawing the councillors attention to the information on the supporting paper.

It was also stated that the park is very well used and after a recent residents survey it showed that residents would very much like to see the park refurbished.

A discussion then took place with one of the councillors stating that they felt APC were being blackmailed into putting half the funds towards the refurbishment and then taking over the park by ADC, or the park would be closed - all agreed. The statement from the report they were referring to is below.

"In the absence of an agreed way forward, our only option will be to remove equipment when it is beyond serviceable repair. In the case of the fence this would likely mean closing the whole play area as a result" TL



After discussion it was agreed that the Clerk would contact APCs ADC councillors with a strongly worded email to officially ask for their help with this matter as well as requesting a copy of the last play park inspection to ascertain the state of the park.

<u>Action</u>: Email to be written requesting the ADC councillors to look into this matter urgently and to receive the latest play park inspection document.


Two grants have now been awarded in 2022/2023 and this totals £1,150.00 The remaining balance is £2,850.00.
