CO-OPTION OF COUNCILLORS ON TO THE ANGMERING SOUTH WARD

The Chairman explained the situation as to why there are two Councillor vacancies for the South Ward. It was advised that Angmering Parish Council (APC) had received one application from a member of the public who was present at the meeting and that another one was going to be submitted however no decision would be made at this meeting as only 10 days had passed since the Elections took place and the Council would like to consider their options before making a decision at the next meeting on Monday 10 June 2019.

Action

The Chairman then gave the member of the public who wished to be Coopted the chance to speak. The member of the public then addressed the Council. Comments were given on various scenarios, possible outcomes and the lack of representation in the South Ward. The member of the public urged the Council to think about what they are proposing to do as three large meetings would need to take place prior to the next full Council meeting on Monday 10 June 2019.

The member of the public thanked everyone for their time and questions and then left the meeting.

The Chairman then opened up the floor for a debate and a lengthy discussion took place. Questions were asked re the number of eligible residents able to vote in the South Ward and it was referenced that the number was approx. 770. The Council felt that they wanted to reach out to the South Ward, and it was agreed by all to give an opportunity to engage this area and hopefully encourage residents to apply to be Co-opted.

The option of another election was brought up but this would incur a cost of between £3-£5k. The Chairman proposed that a group be set up to meet and engage with the residents and give information on why and how to become a Councillor. A leaflet drop will made to all in the South Ward along with dates to come and meet the Councillors to find out more. Cllr. Bicknell volunteered to lead this initiative.

19/018 NEGHBOURHOOD PLAN

The Chairman and Cllr. L Hamilton-Street gave an overview of the Neighbourhood Plan and a discussion took place with questions asked about the amount of work to be done. Cllr. Bicknell asked if we could defer working on the Plan, but the Chairman advised we were being pressed for this.

The possibility of appointing professional assistance was then discussed at length. An amount of £2k was indicated as the amount needed to start this process as grants were still to be applied for. Cllr. N Hamilton-Street **PROPOSED** that £2k was budgeted, Cllr. Oldfield **SECONDED**, all agreed.

19/019 CHANDLERS DELEVOPMENT AND LOAN REQUIRMENT

An update on the planning application and loan requirement was given, a discussion then took place.

The Chairman read the decision required:

To seek the approval of the Secretary of State for Housing, Communities and Local Government to apply for a PWLB loan of up to £1.5m over the borrowing term of 25 years for the new Business Centre, parish offices and other community facilities. It is not intended to increase the council tax precept for the purpose of the loan repayments.

Cllr. Marsh PROPOSED, Cllr. A Evans SECONDED, all agreed.
