- 2. Grateful thanks, to the member of the Public who attended a previous committee meeting and made encouraging comments regarding the efforts of the P&I Committee. I think I speak for all to say that that is very much appreciated.
- 3. The Council Chair and Clerk had a meeting with Andrew Griffiths MP and APC District Councillors re planning and other matters
- 4. Still awaiting the report from Ray Drabble regarding the recent Angmering Flood Attenuation Scheme meeting
- 5. We have received information from a resident that the developers of Swallows Gate in Dappers Lane intend to make a bid to put a footpath opposite the site along to Merryfield Crescent. This could mean the destruction of mature trees. This is something to watch out for.
- 6. Also from a resident, motorists are still entering Dappers Lane from the North against the new no entry signs
- 7. In conjunction with the proposed development known as Land North of Water Lane, residents have reported to APC and ADC that large vehicles are blocking Dappers Lane near to the entrance to the site and the entrance/exit onto Water Lane and have requested that ADC look into what they say is a breach of the Highway Code and the Developers Construction Management Plan.

APC feel that this application is in breach of those conditions and that ADC should both monitor compliance with conditions more stringently and hold the developer to account. Application under S106A for the modification of the Section 106 dated 19-03-15 linked to A/51/14/OUT in relation to the Second & Fourth Schedule

(Affordable Housing) and Third & Fifth Schedule (Strategic Highways Contribution).

DECISION: Objection

COMMENT: The Housing Survey Needs undertaken by Action in Rural Sussex (AiRs) 2020 clearly demonstrated that there was a need for affordable housing for local people in Angmering with a percentage showing that their current housing needs could NOT be met by Arun Housing Department. APC is not in a position to check the validity of the viability statement provided and it is presumed that ADC will have an independent check made. It would seem however that the developer is anticipating, after the deduction of the affordable housing and highway costs, a profit of circa 11.5%.

Nationally the current financial crisis has resulted in substantial reductions in the profits of the majority of commercial undertakings and in many cases losses. There seems to be absolutely <u>NO REASON</u> why developers should be singled out for protection from this situation to the detriment of others.

Whilst the specifics listed within the S106 agreement dated 19th March 2015 may have changed, the need for contributions to highways works in and around Angmering has not. The impact of the development on the High Street will require work, both immediately to the east adjoining Cow Lane, and west neighbouring the Spotted Cow and to Roundstone Lane. Beyond this the Parish Council has identified the impact of developments on the lower end of the High Street onto Station Road and from Weavers Hill onto Water Lane, therefore funding to create more effective vehicle movements is needed.

After much discussion APC felt that despite the current financial situation the need for more affordable housing and highways infrastructure within Angmering and the District has not decreased if anything it has increased. APC also feels that reducing the commitment by the developer to honour the agreement made between ADC, WSCC and Roban Garden Centre Ltd on the 19th March 2015 in favour of profits, shows disrespect and total disregard towards the residents in need and the ongoing much needed highways infrastructure in Angmering. Therefore, APC STRONGLY OBJECTS to this application on the basis that the needs of the Parish out way the profits of the developer. It also feels that should the developer be having financial problems then a stop should be made to the continued construction of this site until the developer is financially able to continue and honour that agreement.

APC OBJECTS to this as full site not included and there is no technical appraisal from WSFRS

Managing Trees and the Assessment and
Method Statement seem to clearly layout
how contractors should protect existing
trees, a condition needs to be added that all
protected trees should be fenced off and
seen by the LPA TP Officer prior to
commencement of on-site work. APC
objects as there is no expert comments from
the LPA Tree Preservation Officer

Cllr. Verrinder reported that as a result of its Local Plan Review the SDNP has put out a call for sites for: -

- Development and Offsetting
- Local Green Spaces

Suggested sites must be submitted by midnight on 28th September 2022.

Cllr. Verrinder said that APC must watch for any action by landowners in the APC part of the SDNP who may want to put their land forward for development.

Next planning committee meeting is on 8^{th} September 2022 – no agenda has been published yet.

14 22/089 COMPLIANCE

Cllr. Verrinder reported that OWEC2067 (ADC compliance reference) – Shrublands Construction has begun despite no Construction Management Plan being approved.

15 22/090 APPEALS

The following updates were given:

Land South of A259 – Allowed. Waiting to see if ADC will be going to Judicial Review. Pressure being put on them by way of meeting with Andrew Griffith MP and with emails and correspondence from District Councillors.

Golf Centre Appeal – To be heard on 6th September – APC councillors have been requested to attend. APC have also received sight of the Kingston Parish Council objection.

McCarthy Stone Development – Refused. Awaiting response from developer or another interested developer.

Pound Place (A/112/21/PL) - Footpath – Decision was made on 12th August to allow this appeal.

16 22/091 CORRESPONDENCE

Correspondence had been received regarding the proposed base station upgrade at Poling Furzfield, Dappers Lane.

Whilst APC has no objection to the upgrade of this mast it requests that consideration is paid to the trees and wildlife that live in and surround the mast. Awaiting comments from the SDNP Planning Authority.



17 22/092 CREATION OF SMALL WORKING GROUP TO MAP CYCLE PATHS IN THE VILLAGE AND INVESIGATE THE PROVISION OF MORE FOR THE INFRA STRUCTURE PLAN

This item was discussed at a previous PI meeting.

The Government has encouraged Local Authorities to prepare, as part of their Local Plans "Local Cycling and Walking Improvement Plans" (LCWIP). A year ago, ADC had not done this, but they may be working on this for the review of their Local Plan, however, WSCC do have a plan. APC intend to investigate and map the current situation within Angmering, the condition of those routes and any additional much-needed cycle/walking infrastructure within the Parish and links to other Parishes bordering Angmering Parish boundary.

This item is to be brought to the next Full Council Meeting to find out if any Councillors not on the PI Committee would like to be part of the working group or could assist with advice. It will also be brought to the next PI meeting when the formation of the working group is made.

Action: Add to the next Full Parish meeting agenda in September.

18 22/093 HIGHWAYS MATTERS

Survey - In an effort to understand more about the type of public transport that serves Angmering and the transport needs of the residents of Angmering, APC are undertaking to publish a Transport/Traffic Survey to find out the opinions and needs of the Parish Residents. This survey is now live and can be found on the APC website, APC Facebook page and advertised in our office window and noticeboards.

A259 – Still on track for the end of the year completion – Tarmac is now being laid. However, the promised monthly newsletter from WSCC appears to have ceased the last being issued on the 4th July.

Cllr. Marsh has concerns regarding safe crossing areas on the A259 as there currently does not seem to be any points to cross or signage by the roundabout next to Worthing Audi. Highways have been informed and will be acting on this as soon as possible.
