4 24/064 THE CHAIRS REPORT ON ANY MATTERS OF INTEREST AND THOSE OUTSTANDING FROM THE PREVIOUS MEETING, BUT NOT INCLUDED ON THIS AGENDA. TO ALSO INCLUDE AN UPDATE ON THE STATUS OF THE

A copy of the Chairs report had previously been sent to all committee members and was accepted with no questions being asked. The report was also uploaded onto the APC website.

The following additional items were added:

The Chair commented that an e-mail had been received from a local resident expressing his views on the Roundstone Crossing and the increasing obstruction to the free flow of traffic at the Blue Star Roundabout. These views are highlighted in the attached Roundstone level crossing reports. We now await the progress of this situation.

Additional items:

a) Angmering Advisory Group Meeting

There was a group meeting yesterday to discuss the proposal for development west of Bewley Road and the social housing application relating to "Fairways Gardens" at the Golf Centre. In attendance were representatives from both developments, ADC officers and Cllr Urquhart WSCC, Katie Herr, Cllrs Verrinder, Hamilton-Street, Oldfield for the Parish Council and D/Cllr Bicknell for ADC. The meeting was Chaired by D/Cllr Cooper. Detailed information will be produced at a later date.

b) Arundel Road / A27 Junction

Concern has been raised over the flow of traffic along the northern end of Arundel Road. This will over the next 3-5 years be exacerbated with the movement of construction vehicles to 3 possibly 4 development sites on the northwest side of Arundel Road. Whilst highways matters are the remit of WSCC, the matters relating to the actual developments is the remit of the ADC Planners who are asked to review the movement to/from the sites to ensure that there is a co-ordinated plan which will not have a major disruptive nature to the residents of and visitors to Angmering who have tolerated enough disruption over the last 10 years. This was discussed at length and Cllr Bicknell agreed to investigate the junction situation and report back to a future committee meeting. APC will insist that all construction vehicles, enter and exit these sites via the A27 and do not use any route south along Arundel Road or through the Village Square and that no constructor vehicle is parked on Arundel Road.

 - Parking Survey Angmering
 - Angmering Sports Hub Project
 - SDNP Local Plan Review

d) ADC Call for Sites 2024

There has been a news release that ADC are now calling for their annual request for development sites throughout the district. They are asking for land for the following: -

Housing. Business, Leisure & Tourism. Gypsy/Traveller. Biodiversity Net Gain. Blue/Green Infrastructure (Rewilding, natural flood mitigation, renewable energy).

DECISION: Objection

COMMENT: This was discussed at length and APC feels that this application is incomplete. As the entrance into the site is now completed, motorists are still using the former entrance at the roundabout which appears to be unrestricted and uncontrolled. APC also has major concerns relating to the cycle path/public footpath (as shown on the plan) which will cross from the site over the B2140 near the A280/259 roundabout as this could prove to be a point of danger with the potential for a fatality. APC would suggest that signage is placed warning motorists off the A259 into the B2140 of the possible conflict with cyclists and pedestrians.

DECISION: Objection

COMMENT: This was discussed again at length and whilst APC supports the decision by Environmental Health on the produced Dust Management Plan it is still concerned over the lack of response to its objection comments of the previous application. APC is still concerned over the lack of more information or consideration regarding:

- Vehicle movements timetable i.e. number of vehicles per day over the stated 30-month period, how many HGV can be expected per day during the construction period.
- Routing HGV not to exit the site and go through the Conservation Area or Village Square.
- <u>Damage</u> Repairs to public footpaths and culvert which has a weight limit

BMW House Chandlers Garage Ltd Water Lane Angmering Information has been received that the developer has requested from WSCC - a Temporary Traffic Regulation suspending parking along Water Lane from Nos 17 – 24 to aid the movement of large vehicles. This takes effect from 7th August 2024 to 28th January 2024. Access for Emergency Services, Residents and pedestrians is to be maintained. APC feels this is a positive response to the previous request and applauds the developer for respecting it and obtaining it.

This was discussed at length and agreed that as this was a Highways Agency remit, the report should be forwarded to them for consideration. We now await comment from them.
